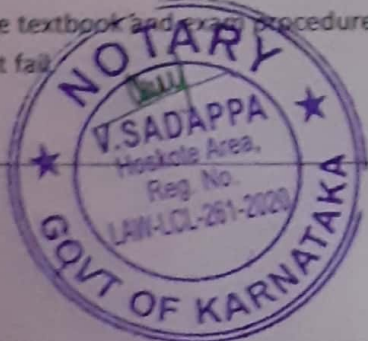

Conditions

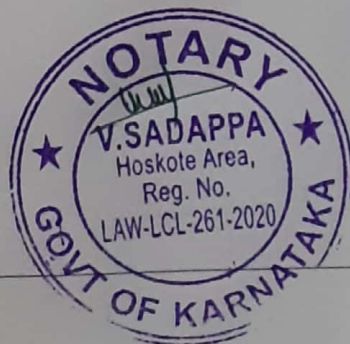
1. This registration is subject to Rule 3[5][4].
2. The Governing Council shall compulsorily comply with all the conditions mentioned in Rule 4[4].
3. Subject to provision of school premises, area, building, furniture, staff, financial facilities etc. Under no Circumstances shall the said educational institution open more departments without the prior approval of the Government.
4. The school shall be run only in the same Medium, manner and at the same place as sanctioned and shall not be allowed to change the place for any reason and shall run by same Governing council.
5. This educational institution shall comply with all Government orders and rules in force and issued from time to time in relation to educational institutions. The Karnataka Education Bill 1983 [Karnataka Act No:1:96] Acts made there under and rules framed there under shall be strictly followed.
6. As per this high school registration vide Government Notification No.: ED175 PMC: 95 Dated: 07-09-1998 And Dated 29-12-1998 school is permanent non-grant. Giving a letter of consent certified before a notary in Rs 10-00 Stamp paper that the governing body does not want any grant from the government.
7. Karnataka Private Educational Institutions [Appointment, Service Conditions and Provisions of Employees of Private Aided Primary and Secondary Educational Institutions] Rules, 1999 shall be strictly followed.
8. Only the textbook and exam procedures prescribed by the department and government should be followed without fail.



9. Minimum attendance shall be 25 in each permitted class.
10. Only trained and qualified teachers as per department rules should be appointed. Under Article 8 of the Karnataka Provisional Bill vide Clauses 36-39 Accreditation and Provisional Accreditation (Renewal) of all schools Should be done time to time.
11. Medical examination of students should be done as per rules every year.
12. For starting the school, the institution shall keep a security deposit in the joint account of the District Deputy Director and the Governing Body.
13. According to the rules of Karnataka Education Bill, the facilities like furniture, teaching equipment, library books, playground, school building etc. should be provided in one year. If not, the registration will be cancelled.
14. School opening and student enrollment information should be reported to this office within three months of school registration or commencement of the academic year. If the school is not opened and any conditions are not complied with, this order will automatically stand cancelled.
15. Separate toilet facility for girls and boys should be compulsorily provided in school and clean drinking water facility should be provided.
16. Hearing of proposal to Deputy Director for first accreditation. The Deputy Director shall obtain information from the check list of Annexure-3 of the Education Act and the Government order dated 30-09-2007 and on this basis issue the first accreditation compulsorily within three months of the commencement of the school. In case of non-accreditation within the prescribed period, the registration will be canceled immediately.
17. School Should check and ensure that the school building is safe from accidents like fire, storm, electrical accident etc. Compulsory Placing a notice in front of the school prohibiting the sale of tobacco products within 100 yards of the school premises.
18. The department reserves the right to cancel the registration, if the school management board provides any wrong information.
19. Government Notification No: ED 369 PGC 2014, dated 11.11.2014 and this Office Circular dated 14.11.2014 shall ensure that the conditions are complied with.
20. The conditions vide Government Notification No. ED 709 PGC 2017, dated 07.03.2018 and this Office Circular dated 26.03.2018 shall be ensured.
